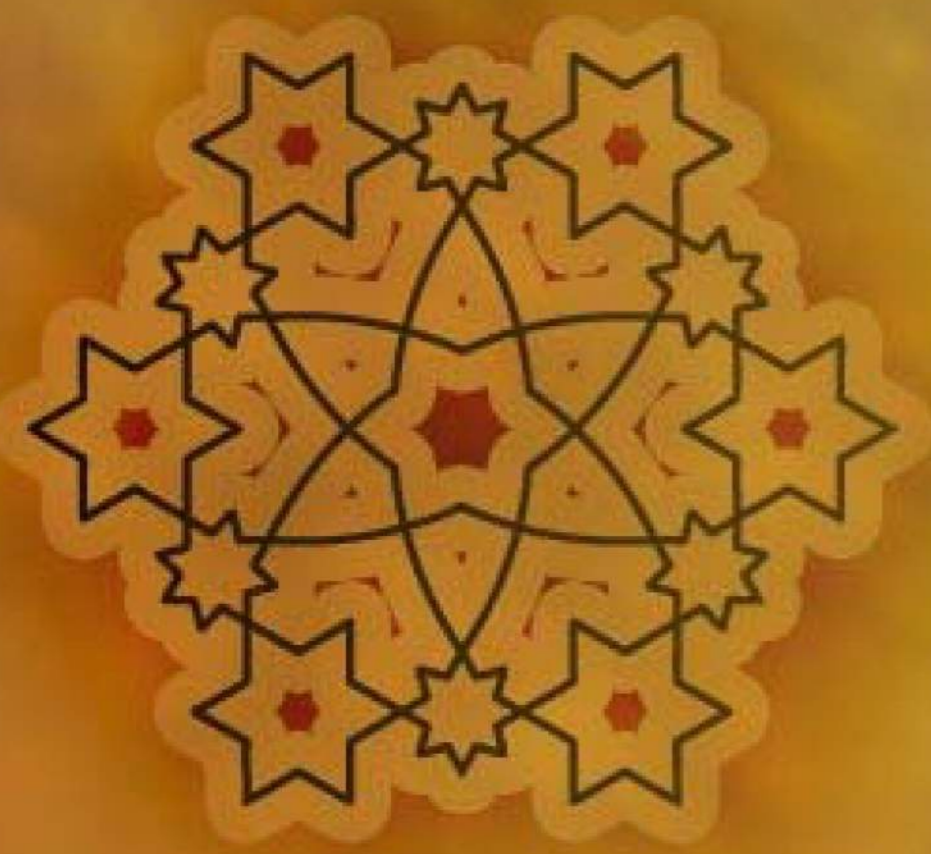

Holly Qur'an:

Basic rules of Haram (unlawful)

Specifically pointed out in 4 chapters and 15 verses. e.g.

Al Baqarah: 173 God has forbidden you to eat that which has not been properly slaughtered, blood, pork, and the flesh of any animal which has not been consecrated with a mention of the Name of God. However, in an emergency, without the intention of transgression or repeating transgression, one will not be considered to have committed a sin. God is All-forgiving and All-merciful.

Al-Ma'ida: 3 It is unlawful for you to consume the following as food: an animal that has not been properly slaughtered, blood, pork, an animal slaughtered and consecrated in the name of someone other than God, an animal killed by strangulation or a violent blow, an animal killed by falling down, an animal which has been gored to death, an animal partly eaten by a wild beast before being properly slaughtered, an animal which has been sacrificed on the stone blocks (which pagans worshipped), and any flesh divided by casting superstitious and gambling arrows (a pagan tradition), which is a sin

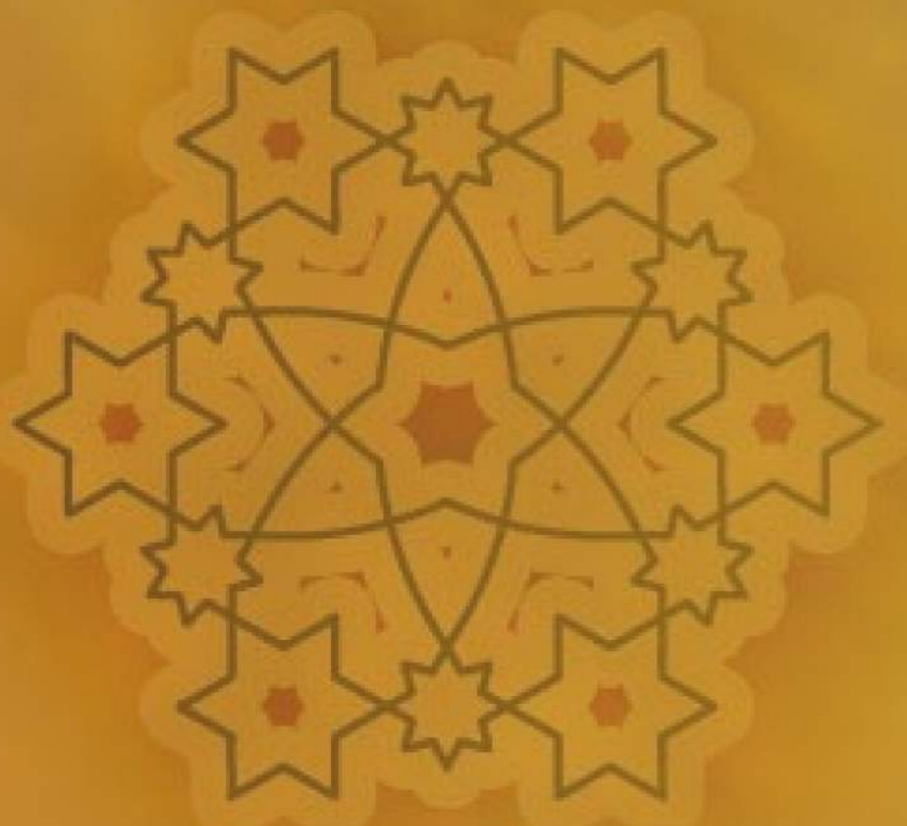

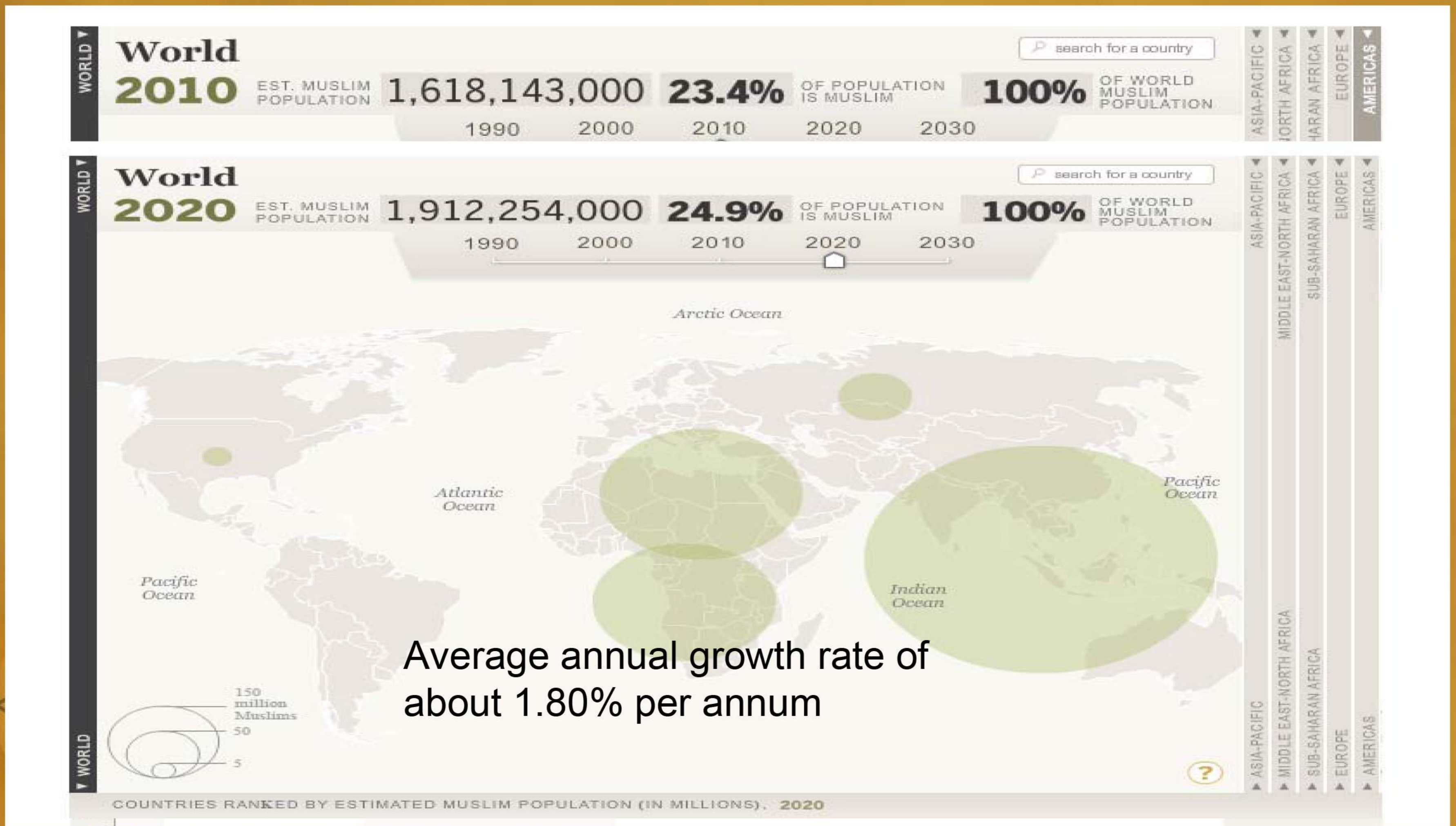

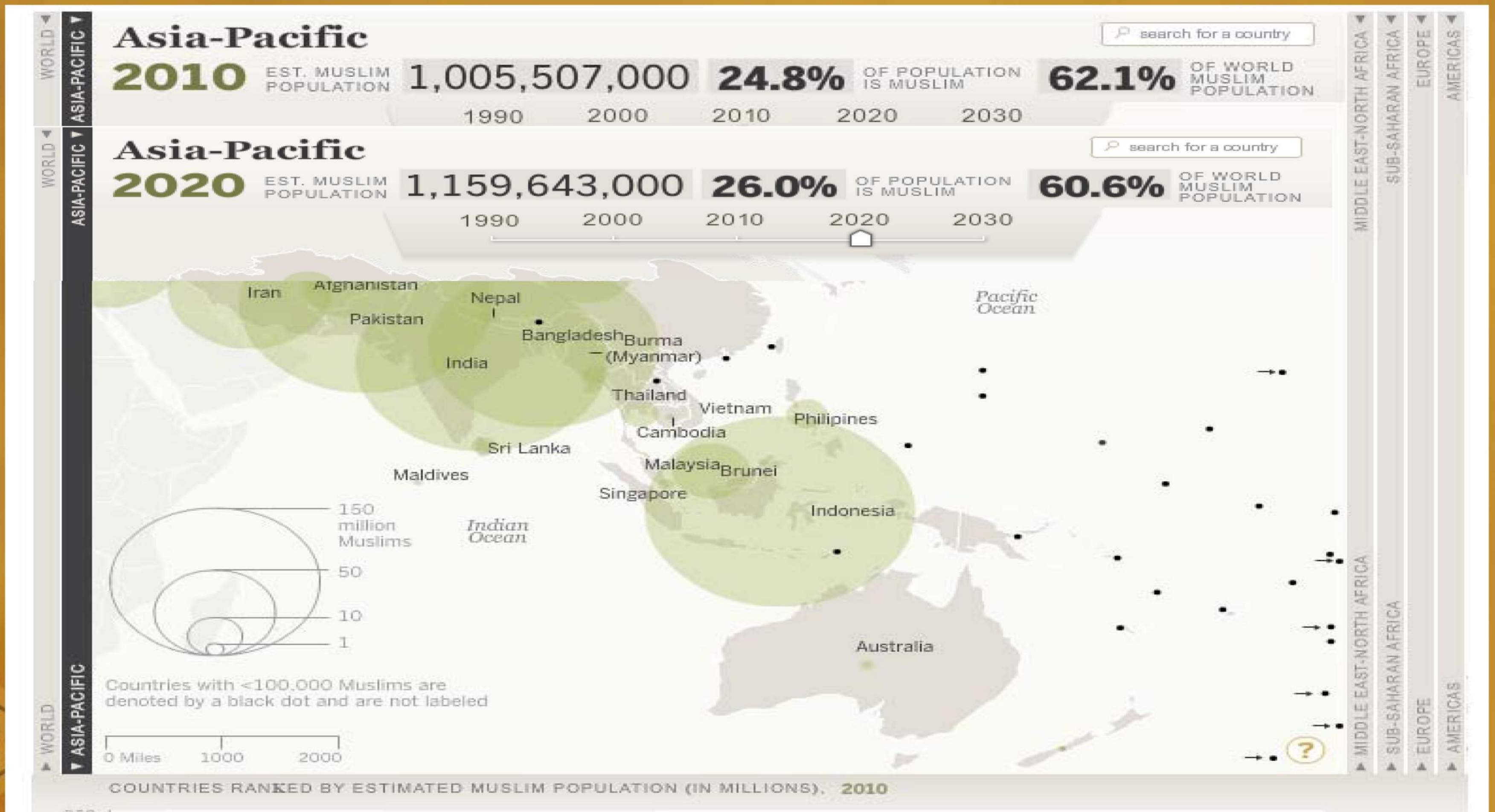

Current trends in the Market World and OIC Countries

- GDP of the world – based on PPP – has witnessed an increasing trend over the period 2009-2013, reaching \$87.0 trillion in 2013 compared to \$70.6 trillion in 2009.
- Developing countries witnessed rapid increase in GDP from \$33.0 trillion in 2009 to \$43.9 trillion in 2013
- GDP recorded at \$43.1 trillion in 2013 compared to \$37.6 trillion in 2009 for developed countries.
- OIC countries also witnessed an increasing trend in economic activity from \$7.7 trillion in 2009 to \$9.8 trillion in 2013.
- The average GDP per capita in OIC countries also increased from \$5,110 in 2009 to \$6,076 in 2013.

Economic Trends in OIC

- The average real GDP growth rate of the OIC countries slowed down to 3.9% in 2013 from 4.6% in 2012
- Average growth rates of the OIC countries are forecasted at 4.1% in 2014 and 4.9% in 2015
- Average growth rates developing economies, excluding China and India, would be 2.8% for 2014 and 3.4% for 2015.
- Average shares of the value-added by sectors in the total GDP:
 - ✓ Service sector (65.8%),
 - ✓ Industrial sector (29.7%)
 - ✓ Agriculture (4.4%).

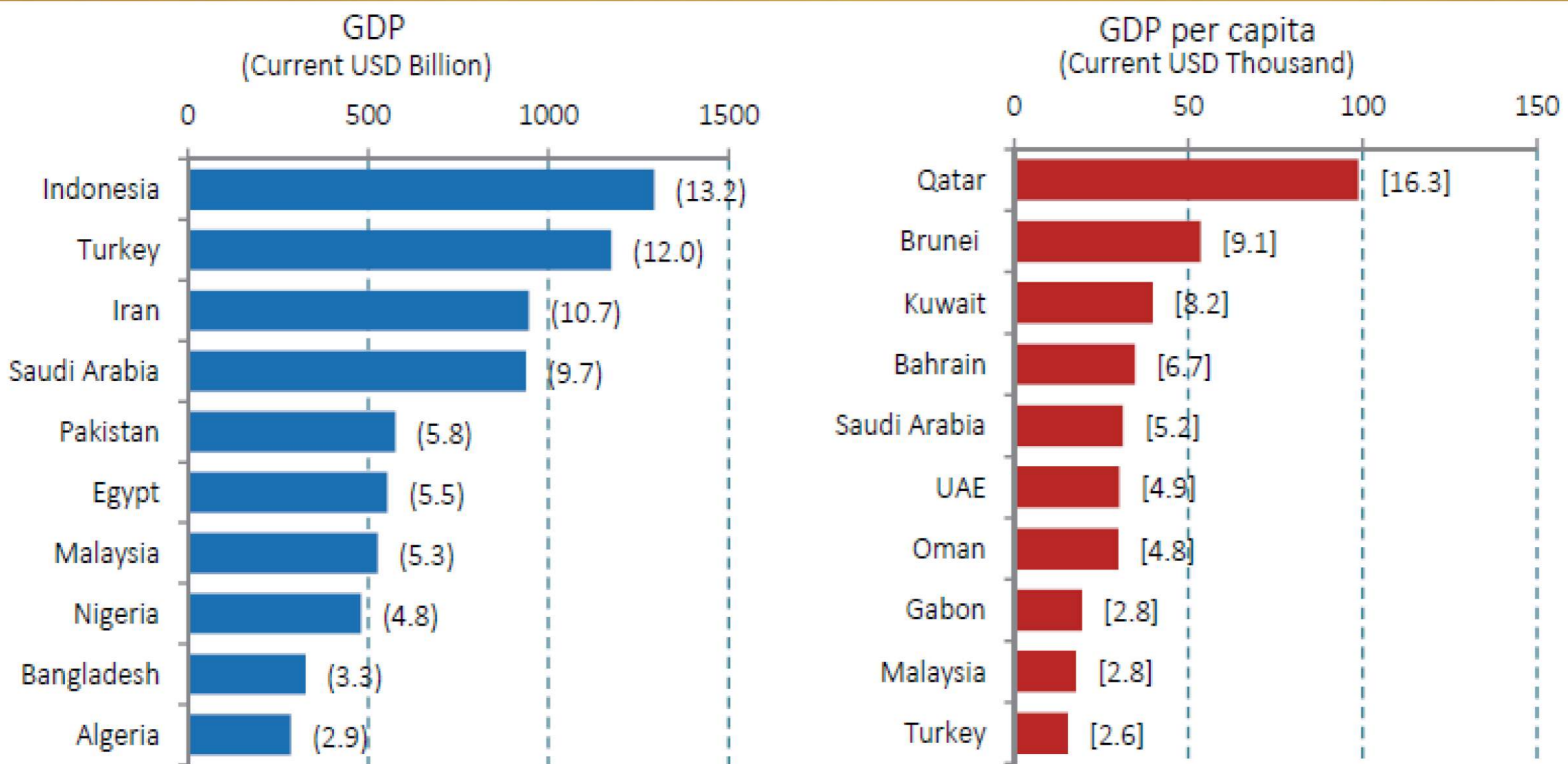

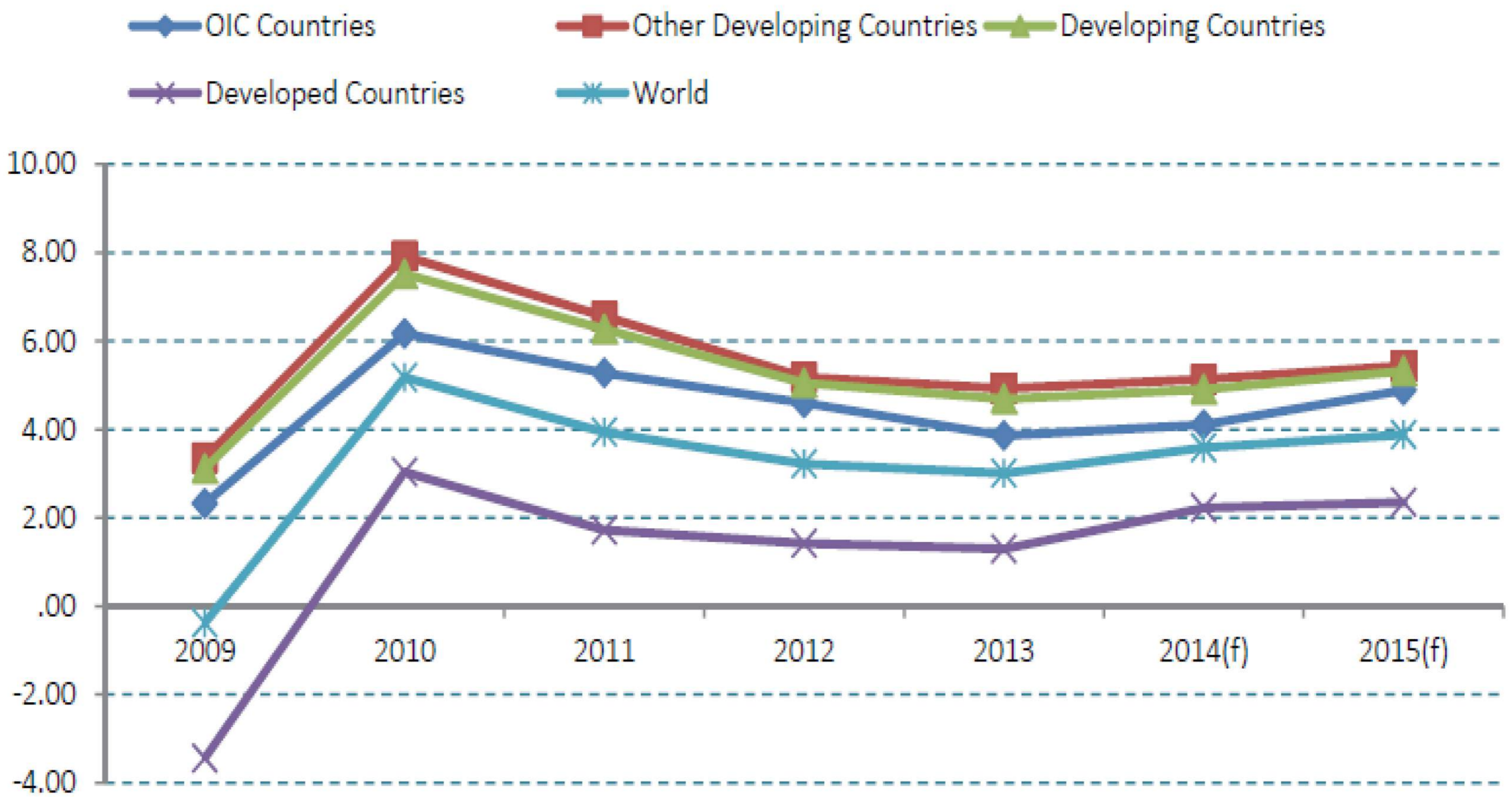

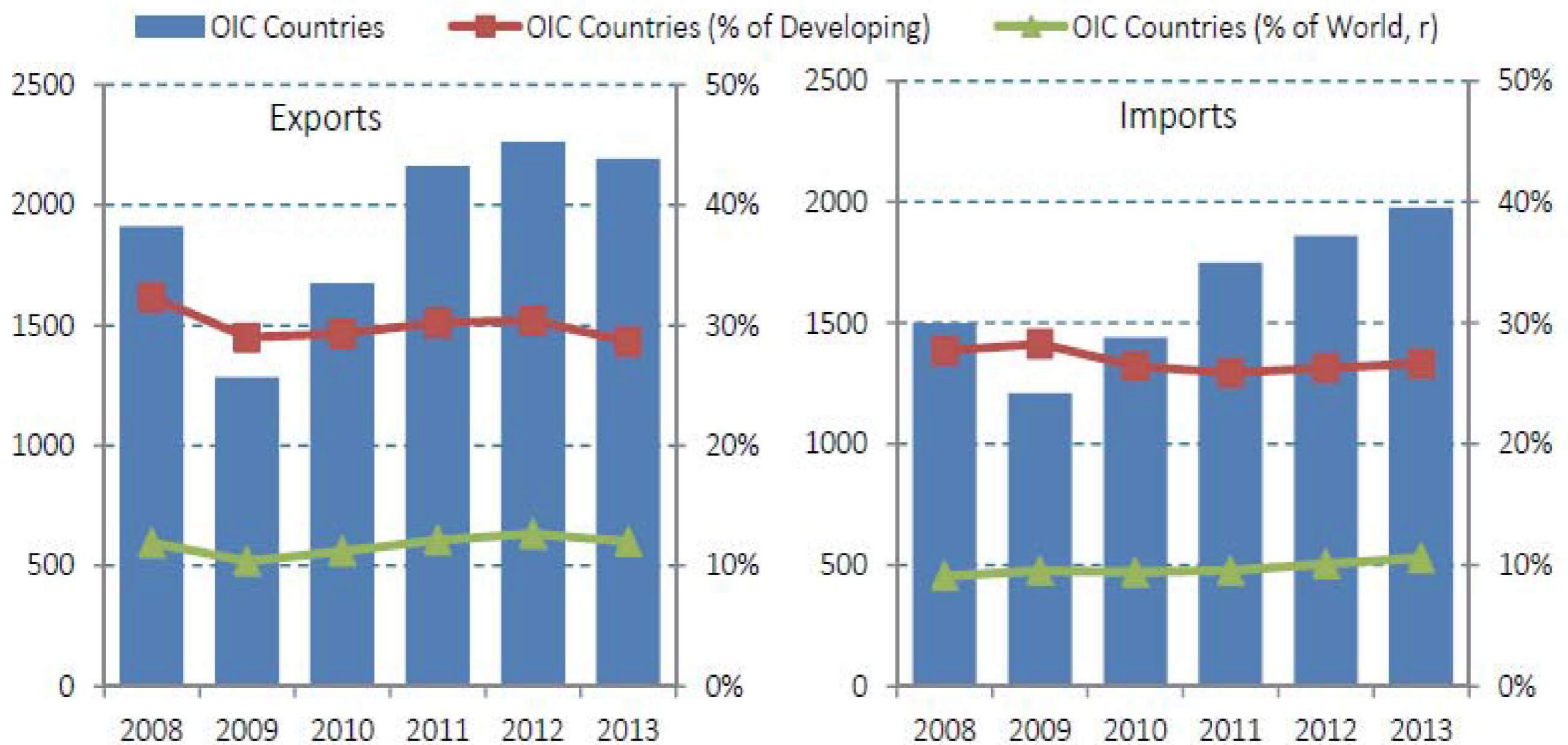

- ✓ Outbound Muslim tourists seeking Islamic compliant services
- ✓ Japan Tourism potentials are attractive enough for any tourist , some improvements in Islamic Services
- ✓ Muslim tourists visited Japan in 2014 increased to 700,000
- ✓ Indonesian visitors to Japan increasing 37% on 2012 from January to September 2013 - totaling 98,200 visitors, and 21% up from Malaysia - totaling 104,200.
- ✓ Starting from 1 July 2013, the Japanese Government stopped requiring visas for tourists from four member countries of ASEAN - Thailand, Brunei, Singapore and Malaysia. This has helped increase visitor numbers from the region and tourism facilities in Japan
- ✓ With Islamic compliant services Japanese Tourism sector could be booming in coming years

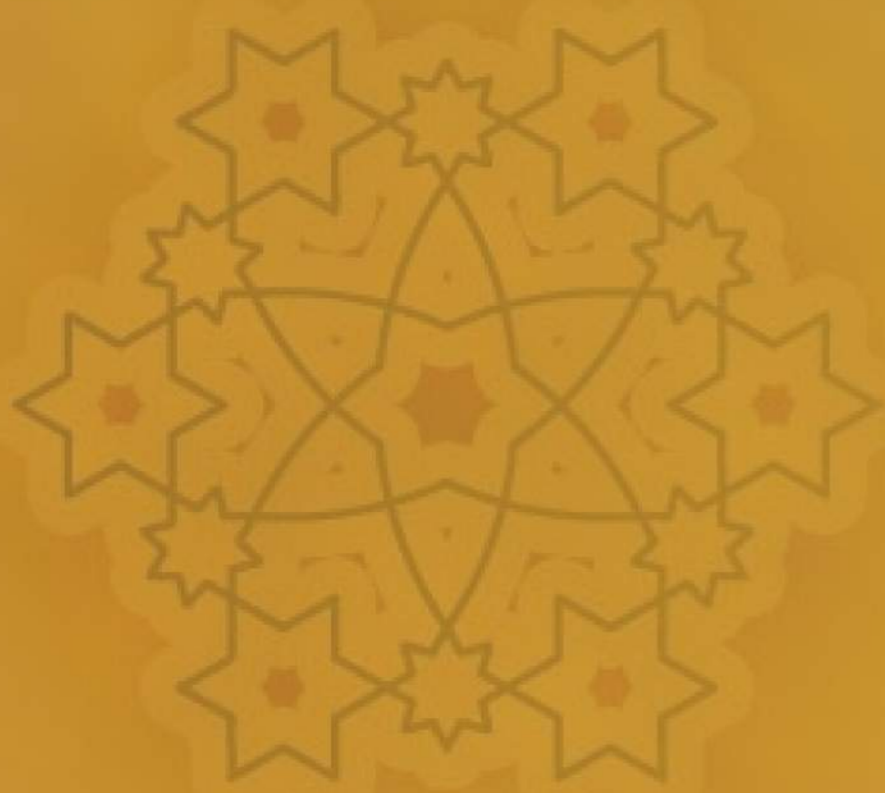

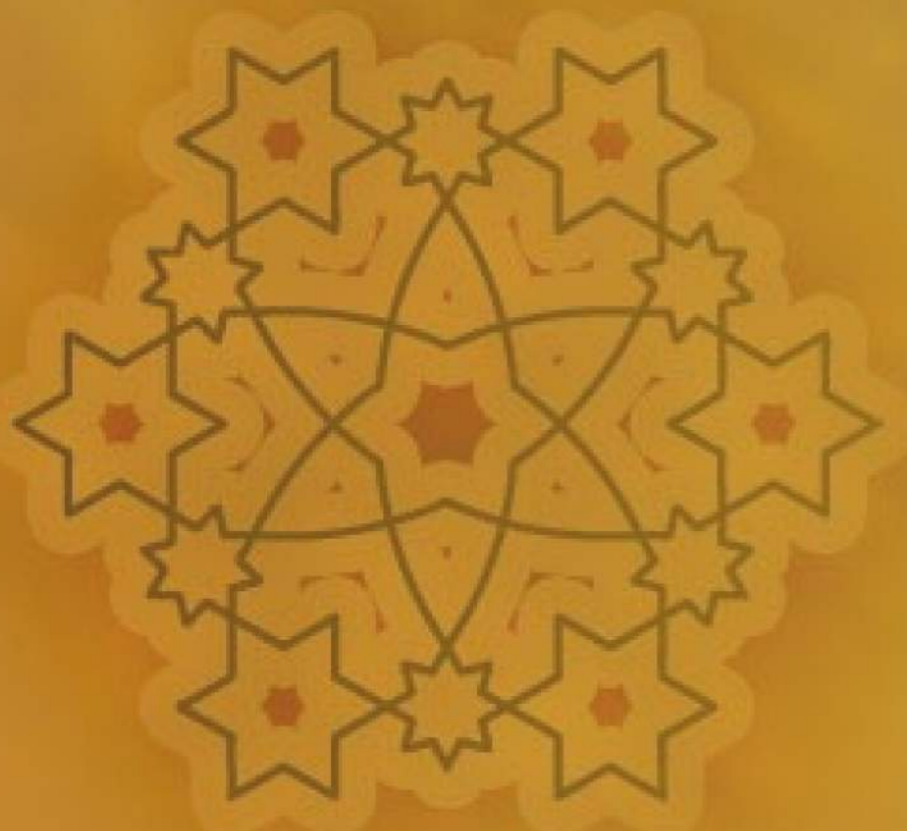

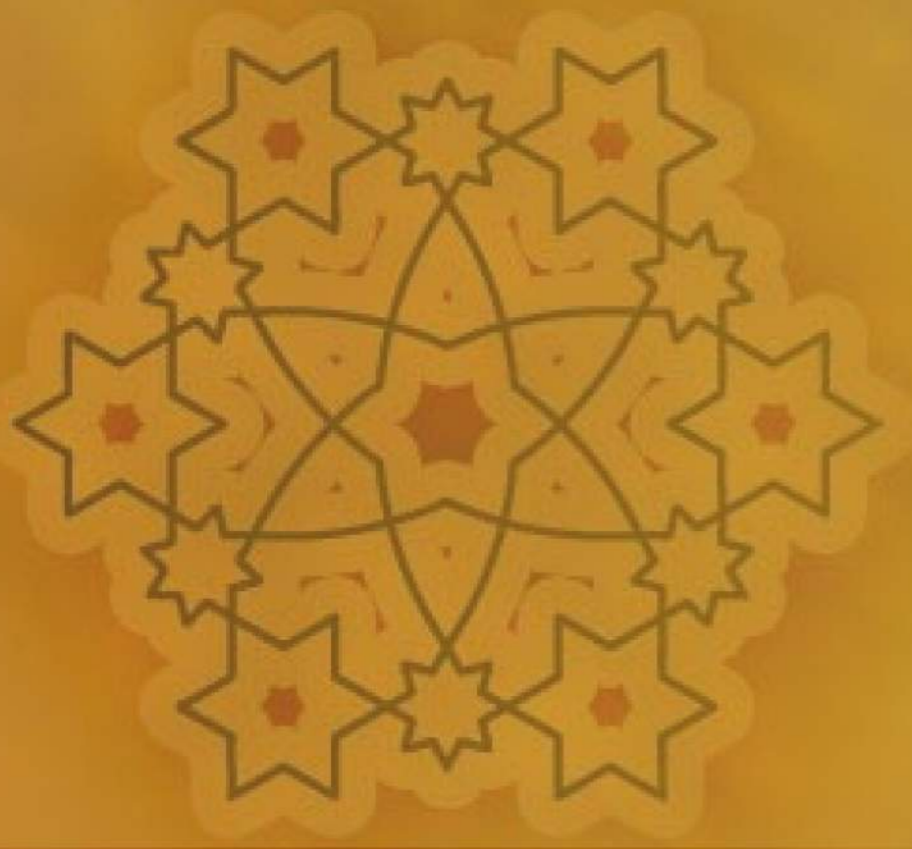
